SUMMARY ANNUAL REPORT

For Air Line Pilots Association, International Pilot Welfare Benefit Trust

This is a summary of the annual report of the Air Line Pilots Association, International Pilot Welfare Benefit Trust, EIN 36-0710830, Plan No. 523, for period November 1, 2021 through October 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Anthem Health Plans Of Virginia, Inc., Metropolitan Life Insurance Company, Metropolitan Life Insurance Company, Reliastar Life Insurance Company and Reliastar Life Insurance Company to pay dental, life insurance, long-term disability, Accidental Death and Dismemberment, Critical Illness and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending October 31, 2022 were \$9,690,373.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending October 31, 2022, the premiums paid under such "experience-rated" contracts were \$5,157,116 and the total of all benefit claims paid under these contracts during the plan year was \$3,671,872.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$73,820,779 as of October 31, 2022, compared to \$87,618,025 as of November 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$13,797,246. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had a total loss of \$948,544, including employee contributions of \$12,951,287, realized losses of \$268,499 from the sale of assets, earnings from investments of \$13,631,754, and other income of \$422.

Plan expenses were \$12,848,702. These expenses included \$1,647,994 in administrative expenses, and \$11,200,708 in benefits paid to participants and beneficiaries.
